I understand that there are inherent and other risks involved in the Event and injuries are a common and ordinary occurrence and I freely assume those risks and accept full responsibility for any and all such damage or injury which may result. I am advised to wear all the protective gear for my protection and safety while playing in the Event and I further state that I am in proper physical condition to participate in the Event and I am aware that my participation could, in some circumstances, result in physical injury.

Junior players under 19 years of age may play for any club in the NWCL with express permission from their own club. This waiver covers all NWCL events regardless of which club a junior may be playing for.
